CONVERSION OF PERFORMANCE RIGHTS

GALENA MINING LTD ("**Galena**" or the "**Company**") (**ASX: G1A**) advises that it has converted 1,000,000 Class 1 Performance Rights ("**Performance Rights**") to fully paid ordinary shares ("**Ordinary Shares**").

The relevant tranche of Performance Rights is part of the package of Performance Rights issued to Galena's CEO, Alex Molyneux and approved at a General Meeting held 19 October 2018.

The trigger for the conversion of the relevant tranche of Performance Rights is the vesting date, being 1 September 2019 and when

- (a) the Company commences initial physical development works at the Abra Base Metal Project such as initiation of: earth works, decline development, or site infrastructure development (ie. major camp works or air strip development or power plant or infrastructure construction); or
- (b) at least one Project Milestone or Share Performance Milestone has been achieved.

Consequently the Share Performance Milestone has been achieved during the month of April 2019.¹

The Appendix 3B and Notice Under Section 708A in respect of the Ordinary Shares issued are appended to this announcement.

About Abra Base Metals Project

86.67% owned by Galena, the Abra Base Metals Project (“**Abra**” or the “**Project**”) is a globally significant lead-silver project located in the Gascoyne region of Western Australia (between the towns of Newman and Meekatharra, approximately 110 kilometres from Sandfire’s DeGrussa Project).

Galena completed an outstanding definitive / bankable feasibility study (“**FS**”) (see *Galena ASX announcement of 22 July 2019*) for development of a mine and processing facility with a 16-year life producing a high-value, high-grade lead-silver concentrate containing approximately 95kt of lead and 805koz of silver per year after ramp-up. Based on a pre-development capital expenditure estimate of A\$170 million, the FS modelled a pre-tax net present value for Abra (at an 8% discount rate) of A\$553 million and an internal rate of return of 39%.¹
